PROMOTION REGULATIONS

"KITCHENS WITHOUT VAT WHEN BUYING A MINIMUM OF TWO CABINETS"

GENERAL

§ 1

[Organizer's Identification]

The organizer of the promotion "KITCHENS WITHOUT VAT WHEN BUYING AT LEAST TWO CABINETS", hereinafter referred to as the "promotion", is the company Sklepy KOMFORT SA, with its registered office in Łódź at 14 Srebrzyńska Street, entered into the register of entrepreneurs kept by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under KRS 0000267428, share capital in the amount of PLN 85,418,228.14, fully paid up, NIP 851-29-91-593, Regon 320268249, hereinafter referred to as the "Organizer".

§ 2

[Scope of promotion]

1. The promotion applies to purchases in brick-and-mortar stores and in the online store www.komfort.pl I www.komfort.eu 15.05.-18.06.2024 or while stocks last.
2. KOMFORT SA stores reserve the right to extend the duration of the promotion.

§ 3

[Promotion rules]

1. The promotion is conducted on the basis of bonus sales and applies to the purchase of kitchen furniture in stationary stores and in the online store www.komfort.pl and www.komfort.eu.
2. Every Customer who on 15.05.-18.06.2024 places an order, pays an advance payment or purchases kitchen furniture (confirmed by issuing a VAT invoice or a fiscal receipt) in a KOMFORT stationary store or makes a purchase of the above in the online store www.komfort.pl I www.komfort.eu obtains the right to take advantage of the promotion according to the rules set out in these regulations.
3. As part of the promotion for kitchen furniture in stationary stores and in the online store, you are entitled to a discount of -18.7% when buying min. 2 lockers in stationary stores and in the online store, taking into account the restrictions listed in § 4 of the regulations.
4. Method of calculating the "**cheaper by VAT**" discount: in the case of goods subject to the 23% VAT rate, a discount of 18.7% on the gross purchase price of goods is granted. In accordance with the Act of 18.03.2011 amending the Act on tax on goods and services, the 23% tax is calculated on the net amount. For example, in the case of a net price of PLN 100, 23% VAT is added, which gives a price of PLN 123 gross. A discount of 18.7% will be granted on the gross price of the goods amounting to PLN 123. Therefore, the purchase price of the goods after the discount will be PLN 100 (PLN 123 - 18.7% = PLN 100).
5. The "KITCHENS WITHOUT VAT WHEN BUYING A MINIMUM OF TWO CABINETS" promotion includes kitchen furniture offered by KOMFORT.

§ 4

[Promotion Restriction]

1. The promotion to which these terms and conditions apply are valid in stationary stores and in the online store www.komfort.pl I www.komfort.eu on 15.05.-18.06.2024.
2. The promotion does not apply to services.
3. The promotion does not apply to household appliances, accessories, countertops, handles and kitchen lighting.
4. If the time of order fulfillment (delivery) of the ordered products exceeds the Promotion period, the participant does not lose the right to use the promotion – the condition is to place the order on the days specified in point 1 § 4 of the Terms and Conditions.
5. The promotion is calculated only for documents opened during the promotion period, i.e. 15.05.-18.06.2024., i.e. it will not be counted towards the proforma/offer created before the promotion and paid for during its validity.
6. The promotion does not apply to purchases made with the use of a discount card or the use of discount coupons or vouchers of the Organizer.

§ 5

[Identification of entities entitled to participate in the programme]

The promotion is open to individuals and business entities that are customers of a brick-and-mortar store and online www.komfort.pl I www.komfort.eu.

§ 6

[Products Warranty]

The Promotion Participant has all rights under generally applicable laws, including m.in warranty and guarantees provided by manufacturers, for all products purchased under the Promotion.

§7

[Product Return]

1. The customer has the right to return only full-value products purchased within 30 days from the date of receipt.
2. In the event of return or exercise of the right to withdraw from the sales contract of the products covered by the Promotion, the promotion participant is obliged to return all promotional products purchased as part of the Promotion, which are a set.

FINAL PROVISIONS

§ 8

[Changes to the Terms and Conditions]

The organizer, Sklepy Komfort S.A., 14 Srebrzyńska Street, 91-074 Łódź, reserves the right to make changes to the provisions of these regulations at any time

§ 9

[Right to final interpretation of the Terms and Conditions]

In the event of any doubts related to the application of these regulations, the organizer reserves the right to the final interpretation of its provisions. In the event of doubts as to the application of the regulations, the buyer has the right to ask the organizer at any time to properly interpret its provisions.
